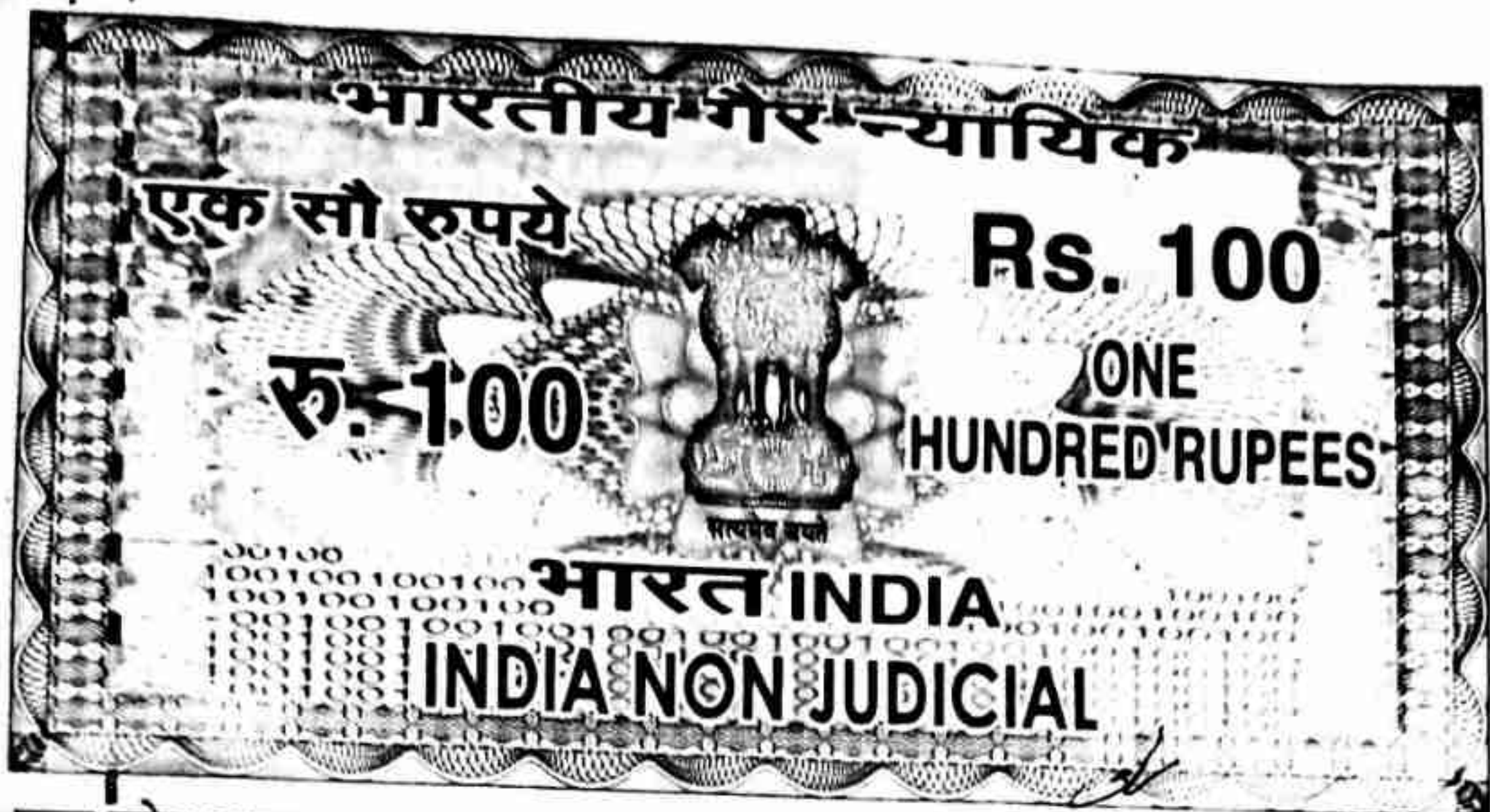

4. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions subscriptions from time to time.
5. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 hereinabove.
6. That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the trust.
7. That for the furtherance of the objects of the trust, the Chief trusty shall have the following powers:
 - (i) Investments, income, expenses, etc will be in the name of the trust only.
 - (ii) Trustees will call trust meetings at least once in 3 months and there shall not be a gape of more than 95 days between any two meetings. Of these meetings, 2 meetings will be held in the presence of Prominent Disciples of Jainacharya.
 - (iii) Trustees shall strictly follow the rules & regulations etc. accepted and formed by trust from time to time for the conduct of the affairs of the trust.
 - (iv) Notwithstanding anything contain in this deed the objects of the trust & the powers of the trustees will be implemented or executed with the written permission of Guruvar/ Munishri.
 - (v) To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, with or without conditions.

Now this indenture witnessed as follows:

1. That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, a sum of Rs. 10000/- (hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.
2. That the name of the trust shall be BRHAMLEN SHREE PUJARI MAHARAJ SIKSHAN SAMITI TRUST and its office shall, for the present, be situate at Village and Post Tiwara Tahshil - Badalapur, District - Jaunpur and/or at such other place or places as the trustees may decide from time to time by 2/3 majority.

- (vi) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- (vii) To convert and deal with the trust property; and/or any investments for the time being.
- (viii) To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other financial securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees in best interest of the Trust.
- (ix) To borrow or raise or secure payments of moneys and also to lend money either with sufficient security.
- (x) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.

- (xi) To open account in the name of the Trust, and/or Institutions run/ conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account Singly by the Chief Trusty or as power delegated by the Chief Trusty through Trustees or by an agent appointed by the Chief Trusty
- (xii) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund
- (xiii) To appoint constituted advocates or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time & remove such advocates or agents and to appoint other or others in his or their place.
- (xiv) To appoint or make provision for the appointment of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe
- (xv) To appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as may be prescribed by the Trustees

- (xxii) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- (xxiii) To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their discretion think fit.
- (xxiv) To apply to the Government, public bodies, municipal and other local bodies, corporation, companies, or persons to provide grant of money and of help, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the trust and
- (xxv) to discuss and negotiate with the Government Departments, public and other bodies, corporations, companies or persons, scheme and other work and matters

- (xvi) To make, alter or modify schemes, rules and regulations for carrying out the objects of the Trust.
- (xvii) To make, alter or modify schemes, rules and regulations for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- (xviii) To start, discontinue and restart any charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- (xix) To set apart and/or allocate the whole or a part of the income or the corpus of the trust Fund or part thereof for any of the objects of the Trust.
- (xx) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- (xxi) To give help by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents to enable such institution, societies, Organization or Trusts to start, maintain, or carry out such charitable objects.

- (a) Three Trustees shall form a quorum for a meeting of the Trustees.
- (b) All matters will be decided mutually by the Trustees.
- (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

14. The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses ought to be paid or borne and every such determination shall be binding and conclusive evidence And Trustees shall not be allowed to spend the income or corpus of the Trust for any purpose not authorized by these presents.

15. The accounting year of the Trust shall be the financial year ending on 31st March every year.

11. The managing trustees for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on -such terms as to retirement and re-appointment as the trustees for the time being considered proper
12. A person shall cease to be a Trustee
 - a) If he dies
 - b) if he is adjudged insolvent or found guilty of an offence involving moral turpitude
 - c) if he is found to have acted against the interest of the Trust
 - d) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year whichever is longer or
 - e) if he is requested to resign by 3/4th majority or as near thereto as possible of the remaining trustees if the if any one asks to resign in case he refuses to resign then trustees will remove him in the next trustee meeting
